A BYLAW OF THE TOWN OF MARTENSVILLE TO ESTABLISH RATES
FOR THE SUPPLY AND CONSUMPTION OF WATER AND THE USE OF THE SEWER
MAIN COLLECTION AND DISPOSAL SYSTEM.

THE COUNCIL of the Town of Martensville in the Province
of Saskatchewan, enacts as follows:

1. SHORT TITLE:

This Bylaw may be cited as Consumer Utility Rates Bylaw.

2. DEFINITIONS:

2.1 "Consumer" means any person or persons who occupies a premises and makes application for water and sewer utility services, and for whom a utility account is established.

2.2 "Premises" means a building or structure or any part thereof, which is connected to utility services and which has a separate metered water supply.

2.3 "Town" means the Town of Martensville, in the Province of Saskatchewan.

2.4 "Utility Services" means the provision by the Town of a public potable water supply to a premises and the provision of a public sewage collection and disposal system from a premises, which is occupied by a consumer.

3. UTILITY RATES AND CHARGES:

3.1 **WATER RATES:** The monthly rates and charges to be paid by consumers of water utility services, shall be as set out in Schedule "A".

3.2 **SEWER RATES:** The monthly rates and charges to be paid by consumers of sewer utility services, shall be as set out in Schedule "B".

3.3 **MINIMUM RATES:** Consumers shall pay the monthly flat rates or minimum charges for utility services, whether or not they actually consumed water from or discharged sewage in the utility system.

3.4 **INTEREST RATE:** Utility rates and charges due over thirty (30) days (one month) shall be charged two and one half percent (2.5%) interest on the outstanding balance owing at the time of the next billing period. This interest shall be charged on the total outstanding balance due over thirty (30) days and is accumulative. (*Amendment Bylaw No. 29-2008*)

4. **REPEAL:**

Bylaw No. P 20-93 and 40-2002 are hereby repealed.

5. **EFFECTIVE DATE:**

This Bylaw shall come into force and take effect on September 1, 2004 subject to regulatory approval by The Local Government Committee, Saskatchewan Municipal Board.

SCHEDULE "A"

MONTHLY WATER RATES AND CHARGES

1. FLAT RATE:

Flat rate minimum charge of \$12 per month.

2. CONSUMPTION RATE:

Additional consumption charge for water used of \$2.25 per cubic metre (\$10.30 per 1,000 gallons).

SCHEDULE "B"

MONTHLY SEWER RATES AND CHARGES

1. FLAT RATE:

Monthly charge of \$22.00, unless otherwise stipulated in Section 2.

2. VOLUME RATE:

The following consumers shall pay a monthly charge of twenty (20%) percent of the monthly water consumption charge, subject to a minimum monthly sewer charge of \$22.00.

2.1 Car Washes

2.2 Hotels and Motels

2.3 Laundromats

2.4 Institutions and Special Care Homes for the accommodation of persons, including lodges, dormitories, nursing homes and hospitals.

2.5 Residential premises containing three or more self contained dwelling units which do not have a separate metered water supply.

2.6 Restaurants

2.7 Schools
