*What is the difference between the regular and simplified appeal process?

Regular appeal process: Any written material and photographs you provide in support of your appeal must be submitted to BOTH the Secretary of the Board of Revision and the City assessor at least 20 days before the date of the hearing.

<u>Simplified appeal process</u>: If you qualify for a simplified appeal process and request it on the Notice of Appeal, you can provide any written material and photographs in support of your appeal to the Board of Revision and City Assessor at your hearing. However, to avoid delays at your hearing, you are encouraged to provide your material to BOTH the Secretary of the Board of Revision and the City Assessor at least 20 days before the date of your hearing. You are eligible for the simplified appeal process if your appeal is for:

- > a single family residential property or residential condominium; or
- > any property that has a current fair value assessment of \$250,000 or less.

The written material you provide for either process should identify why you feel there is an error in your assessment.

Note: An appeal fee has been established by bylaw and must accompany this notice. An appeal against your assessment value <u>does not exempt you from paying taxes on time or from late payment penalties</u>. If an appeal is successful an adjustment will be made to your account, and the appeal fee will be refunded. Penalties incurred from nonpayment WILL NOT be refunded.
