These lands are currently within the Rural Municipality of Corman Park No. 344. Boundary alteration is also referred to as 'annexation'.

Reason for Boundary Alteration –

The proposed boundary alteration will allow for the City of Martensville to bring City-owned land and City infrastructure into City limits, and enable short to medium-term growth.

Objections – Any person may file a written objection to the proposed boundary alteration. The written objection must be received by the City of Martensville, Box 970, Martensville, S0K 2T0 **on or before 5:00 p.m. August 4th, 2017**. If any written objections are received on or before that date, City Council will conduct a public meeting. If a public meeting is to be held, a separate notice will be published.
