



CALL FOR APPLICATION: APPOINTMENT TO REPRESENT THE CITY OF MARTENSVILLE ON THE

NORTH CORMAN DISTRICT DEVELOPMENT APPEALS BOARD

Public notice is hereby given that the Council of the City of Martensville invites its residents to consider serving on the North Corman District Development Appeals Board to fill a current vacancy to represent the City of Martensville. The North Corman District Development Appeals Board is a joint development appeals board serving the member municipalities including Martensville, Warman, Dalmeny, Osler, Langham, and the RM of Corman Park.

PURPOSE

The purpose of the North Corman District Development Appeals Board is to adjudicate appeals under the provisions of The Planning and Development Act, 2007 including appeals regarding minor variances, holding provisions, demolition control districts, architectural control districts, misapplication of the Zoning Bylaw in issuing a development permit, refusal to issue a development permit because it would contravene the Zoning Bylaw, and any of the conditions of a Zoning Order issued on a property.

TERM

The term will be for three (3) years.

MEETINGS

The meetings are held, as required, at the R.M. of Corman Park No. 344 Council Chambers at 111 Pinehouse Drive, Saskatoon, Saskatchewan. Members receive remuneration for each meeting attended and will be provided with training as required.

APPLICATION REQUIREMENTS

Citizens who wish to take an active role on the North Corman District Development Appeals Board must submit an application form, together with a résumé and two letters of reference.
